IN 2012, THE FOUNDATION GAVE GRANTS TOTALING \$1.6 MILLION TO SUPPORT THE ENHANCEMENT OF THE LIBRARY'S COLLECTION. THOSE DOLLARS ALLOWED THE LIBRARY TO BUY BOOKS, AUDIOBOOKS, DVDS AND MUSIC RECORDINGS FOR ADULTS, TEENS AND CHILDREN, MAKING MORE THAN 45,000 NEW ITEMS AVAILABLE ON LIBRARY SHELVES ACROSS THE CITY. APPROXIMATELY 25% OF THE 50,000 NEW EBOOKS AND E-AUDIOBOOKS ADDED TO THE LIBRARY'S ONLINE COLLECTION WERE FUNDED BY THE FOUNDATION.
